## Overview

This upgrade includes the following:

- Replacement of missing parts (ECU is required for this)
- Testing and checking of ECU
- Installation of genuine K-Pro 4 circuit board
- Return shipping (FedEx 3-day)

The K-Pro 4 circuit board has a one year warranty. Hondata will test the Honda ECU and make repairs where possible. However, due to the likelihood of prior poor installation, no guarantees of continued correct ECU operation can be made.
