

S300 V3 Upgrade Form



Overview

This upgrade replaces the green or red board S300 with a new Bluetooth equipped circuit board. The replacement circuit board has a one-year warranty.

If Hondata finds that your S300 is functionally damaged, you will have the option of: (1) Paying an additional \$100 for the upgrade; (2) Getting the old S300 & ECU sent back to you in its as-is condition. (shipping fees: \$40 California, \$50 Out of State and/or \$100 International).

S300s without serial numbers cannot be processed.

Before you send to Hondata

- Make sure you have downloaded and saved your calibration to your laptop/hard drive before sending to Hondata.

Please send the following items to Hondata

- ECU and S300 (both must be in working order)
- Both pages of the form, signed and dated on the last page
